- PURPOSE.** Item P-625, Coal-Tar Emulsion Sealcoat, is withdrawn effective the date of this Change.
 - BACKGROUND.** An interim standard to be used in lieu of Item P-625 is contained in Engineering Brief No. 46 issued by the Engineering and Specifications Division, AAS-200. The interim standard is based on recommendations contained in Report No. DOT/FAA/PM-87/9, II, Criteria for Coal-Tar Seal Coats, dated January 1990. Copies of this report can be obtained from the National Technical Information Service (NTIS).

The major result of the report was the development of a mix design procedure for coal-tar emulsion sealcoats. The procedure can be used to formulate mixtures of coal-tar emulsions, water, rubber additives, and sand that meet criteria developed during the study. It includes test methods, test criteria, and a sequence of steps for selecting optimum quantities of the different components of coal-tar emulsion sealers. The procedure is sufficiently well developed so that it can be used to check properties of coal-tar emulsion sealcoat formulations proposed for use.

However, since the mix design procedure and associated tests have only been conducted in a research laboratory, Item P-625 will not be revised at this time. The interim standard contained in Engineering Brief No. 46 shall be used until sufficient data has been collected to validate its performance under field conditions.


